


In these strained economic times your Town Council has been required to prepare a budget for the coming municipal year which starts in April, this includes setting a precept, ie the Council Tax. Your Town Council has worked hard to continue to provide facilities and services while also continuing to serve the citizens of Sevenoaks. Despite inflation being in double figures and the cost of essential equipment, power and other commodities etc soaring, the Council has applied the lowest possible increase to the Council Tax. For next year a Band D household's tax will be £139.17 an increase of £ 6.50 which is 13 pence per week.


The additional good news is that the most recent forecast states that the UK is likely to avoid a recession and thus we may, with hope, look forward to the best possible year ahead.

SEVENOAKS TOWN NEIGHBOURHOOD PLAN

After many years of consultation and voluntary work there is now the chance for Sevenoaks residents to have a vote on the future of their town.

The Referendum Date for the 1st Sevenoaks

Neighbourhood Plan

will be 4th May 2023

(alongside local elections)

Sevenoaks Town Council has worked with the local community for several years in creating a Sevenoaks Town Neighbourhood Plan (STNP) and we are grateful to the many residents who have given their time voluntary to progress the Plan. The benefits of which have been outlined in this document.

The Mayor of Sevenoaks, Cllr Rachel Parry said: "Last Thursday Sevenoaks District Council unanimously agreed that the Sevenoaks Town Council's STNP will provide a great deal of protection for our town's buildings and new developments. When speaking of the Plan Cllr Peter Fleming spoke warmly of the excellent cooperation between the District and Town Council. The District Council unanimously voted for the arrangements for the Sevenoaks Town Neighbourhood Plan (STNP) to be the subject of a public referendum on 4th May this year. The STNP has been the subject of extensive consultation throughout the town, led by our Town Council, and in its final form received strong support and praise from His Majesty's Planning Inspector.

The Independent Examiner's Report on the Sevenoaks Town Neighbourhood Development Plan was received in December 2022 and was one of the final stages of the Plan's progression towards Referendum. The Inspector required some minor modifications which related to emphasis and clarity on matters within the document which have been adopted alongside any of the minor amendment suggestions received during public consultation that have been agreed to be relevant.

The Independent Planning Examiner provides the following overview of the STNP and positive comments including below:

Overview: "It is evident that significant effort has been invested in the preparation of the STNP and the resultant document it well presented and clear. The identification of potential and allocated development sites and the identification of constraints and opportunities for those sites, will undoubtedly help in future decision making process. It is clear to me that the implementation of the policies in the STNP (as modified) will secure the realisation of the Town Council's Vision and that Sevenoaks will retain its attractive characteristics while at the same time ensuring that a sustainable future is achieved.

- "All proposals [...] will enhance the sustainability credentials of the town" (4.33)
- "Improvements would enhance the pedestrian experience in the town centre" and "ensure that the character of Sevenoaks is retained and improved" (4.34)



- The implementation of Policies E1, E3 and E4, which concern the local economy, "will be of benefit to local businesses and the wider community" (4.37)
- Policy D5, relating to development, "clearly sets out the broad approach to providing energy efficient homes which minimise environmental impact", and all "policies (as modified) relating to Development and Housing contribute to the achievement of sustainable development" (4.53 and 4.55)

If successful at Referendum the community of Sevenoaks will have created a Sevenoaks Town Neighbourhood Plan (STNP) which once formally adopted will be used to determine local planning applications and will carry the same weight as Local Plan policies.

Sevenoaks Town Council would like to acknowledge and thank members of the Steering Committee who contributed towards the completion of the Sevenoaks Town Neighbourhood Plan resulting in positive feedback from the Planning Inspector and ultimately a Plan for the benefit of the town.

Sevenoaks Town Council's portable Speed Indicator Device:

Sevenoaks Town Council has invested in a portable Speed Indicator Device to be installed and periodically moved between three locations within Sevenoaks Town, with Bradbourne Vale Road to first host the Speed Indicator Device between 15th February 2023 until 7th June 2023. The purpose of this device is to reinforce the 30mph speed limit in roads near schools which have been identified by the Town Councillors as being especially prone to speeding.

The three locations, which were publicly consulted on between 9th March 2022-20th April 2022, are as follows:

- Bradbourne Vale Road near the entrance to the riding school
- St Johns Hill near Holly Bush Lane
- Brittains Lane near Beaconfields

The device will be circulated between the three sites every 16 weeks, with the direction in which it faces to be changed every 8 weeks. This is in order to comply with traffic sign regulations, and also has the added benefit of limiting the effects of "sign blindness". Also known as "inattentive blindness", this can occur when a driver sees the same traffic signs every day, and therefore stops being as aware of and adhering to them.

Where does the £1,954,749 Sevenoaks Town Council budget come from?

ANNUAL PRECEPT £1,370,074

70% of the budget comes from the domestic ratepayer's precept (council tax). The Town Council does not receive any portion of business rates or government grants.

INCOME FROM SERVICES £510,433

26% of the budget comes from fees and services such as community halls, sports pitches, markets, cemetery, and cafes

RESERVES £74,242

4% of the budget will be from Town Council's reserves, £94.242 will be taken from HLF dedicated reserves to support Bat & Ball Station project during initial years of opening. This is offset by £20,000 budget put into revenue reserves.

Wherever possible the Town Council aims to provide community facilities at the lowest cost possible to reduce the burden on the taxpayer. At the same time providing the facilities that the community wants and needs. This is often achieved by volunteers assisting in this for which the Town Council continues to remain grateful.

There are some facilities which are not commercially viable including maintenance of public open spaces and play areas and youth facilities, these do not generate income as they are free for public use.

Allotments available in Sevenoaks!

Imagine picking your own sun-kissed strawberries. How about sweet corn picked fresh and cooked just minutes later? Salad? You can have lettuce in June — and in January. Do you make your own jam? It tastes a lot better than store-bought and better still when made with fruit from bushes you have lovingly tended yourself. As do freshly dug potatoes and fresh brassicas, which could provide part of your five-a-day throughout the winter.



If this appeals to you, have you thought about having your own allotment? We currently have vacancies at the Quaker's Hall Allotments in Sevenoaks.

Of course, having your own allotment requires time and effort and, like any farmer, you will sometimes battle with elements, be it the 'beast from the east' or the scorching summer of 2022. But the rewards of hard work and patience can be considerable, and you will have the pleasure of working with nature in a beautiful environment where many of the plots offer stunning views of the North Downs.

For families, the allotments provide the ideal opportunity for little ones to engage with the natural environment and discover where some their food comes from; and that hard work in the fresh air also brings health benefits for young and old alike.



With many experienced growers on site, you will also find that help and advice are never far away. Supplies are available at very reasonable prices from the allotment Trading Centre every Sunday, which is where volunteers from Sevenoaks Allotment Holders' Association (SAHA), are on-hand to answer your questions.

Whether you are an experienced gardener or a novice, you can soon become part of the allotment community. Get to know your neighbours at SAHA's monthly Mug & Muffin mornings (throughout the main growing season), at the Solstice Tea or at the annual Apple Day. What's not to love about that? Interested?
