Hello Margaret,

Thank you for forwarding the email from Sevenoaks Town Council regarding their concerns relating to the gritting of the roads on bus route 8 in Sevenoaks town.

Whilst I can very much appreciate their concerns regarding the gritting of the roads in the town area, as I am sure you can appreciate, a great number of the parishes and communities across the county have a number of roads they wish to see added to the primary gritting route, but unfortunately, it is simply not possible for Kent County Council to accommodate all these requests or 'grit' all the roads within the county. As such we need to prioritise the routes and treat the major roads to keep as much of the traffic moving as possible.

In terms of bus route 8 in the town, I am not aware of any specific issues on this route that were experienced in last years' winter, however, I have not received any previous communication from the bus operators or any passengers regarding any issues on this route, so this is the first time that this issue has been brought to my attention.

Unfortunately the primary routes for the 2018/9 winter are all now fixed, so I am unable to make any changes at this time, however, the vast majority of the roads on bus route 8 are currently on the primary gritting route.

As I previously stated we receive numerous requests for gritting of roads that run adjacent to existing primary gritting routes, however, currently all the primary gritting routes in the county are at full capacity, i.e. they carry enough salt for that specific route, as such, to add any new roads to the primary gritting routes means that an existing road needs to be removed.

The gritting routes across the county are reviewed every year and I can assure you that the town council's comments are taken into consideration during this review. KCC also looks at evidence from bus companies who have cancelled routes specifically due to the weather, and schools closing for the same specific reason, and evidence from Kent Police regarding road traffic crashes. This information alongside feedback from residents, parishes and the observations of our own staff and gritter drivers is then reviewed and used to build an evidence case for an additional road to be added to the primary gritting route.

Whilst I am unable to make any changes to the routes for this winter, I would suggest that the town council document any issues they have during any wintery conditions, and feed this information back to us at the end of the winter period, so that this information can be used in the review for the 2019/20
