

#### Proposed improvements to the Sevenoaks water network

Following a public consultation in December 2018 on our plans for a new water main for Sevenoaks, I would like to invite you to a public exhibition where we will announce our proposed route for the new pipe.

Sevenoaks is currently fed by a 12-inch trunk main, which pumps water from our Cramptons Road Water Treatment Works to our storage reservoir in Solefields Road.

This is then gravity fed back into the town during daily peak demand, feeding several smaller distribution mains within our vast underground network.

The existing pipe is already reaching full capacity as the population grows so we need to reinforce it with another pipe.

If we do nothing, parts of Sevenoaks will experience low pressure or no water at all during times of peak demand within the next 10 years.

It is therefore essential that we lay this new water main, to protect tap water supplies for decades to come.

As part of our public consultation, we spoke a range of local interest groups, Sir Michael Fallon MP, the town and district council and the landowners that could be affected by the pipeline route options.

We also carried out ground investigation surveys to provide the technical information we need to identify our preferred route.

The final decision on the route option takes into account a range of factors including cost, work duration, environment, engineering difficulty and socio-economic impact.
