411. Apologies for Absence

There were no apologies submitted.

412. Requests for Dispensations

413. Declaration of Interests

There were no declarations of interest.

414 Minutes of the Meeting held on 12th October 2020

The Minutes of the meeting of the Community Infrastructure Committee held on 12th October were received and agreed as a true record.

415. Community Investment Projects Cash Flows

The Committee received and noted the Community Investment Projects Cash Flows Summary, as at 18th January 2021.

The total unallocated Capital Receipts Reserve was £230,882.

416 2019 Community Investment Plan Projects

416.1 Bat & Ball Centre

It was noted that the Bat & Ball Centre spend at project completion was expected to be £2,916,825 (subject to final account) against a budget of £3,078,805. External funding had been achieved £1.2m from Sevenoaks District Council and £2.5k from Kent County Council: this had reduced the cost to the Town Council to approximately £1.8m as per the original Community Investment Plan 2014.

The Committee congratulated the Town Clerk on her impressive management of the project, including significant uplifts to the original specification, achieved at no additional cost.

It was noted that the Centre was currently being used as an asymptomatic testing centre.

416.2 Multi Use Games Area (MUGA)

Installation had been completed though floodlighting was delayed due to further Lockdown periods. MUGAS were not currently permitted to operate due to public health guidelines.

416.3 Neighbourhood Development Plan (NDP)

It was noted that the current timetable would be reviewed at the Planning Committee. A number of local authority bodies had raised concerns with the government regarding the ability to run elections/referendums safely by May; government guidance was awaited.

416.4 Sevenoaks Business Hub

Construction work on the Business Hub was progressing well, on schedule for completion. Whilst installing fibre optic broadband, the opportunity had been taken to also upgrade the Town Council offices.

The Town Clerk reported that there was good general interest in the facilities and some early discussion regarding the running of the Hub.

416.5 Darent Valley Community Rail Partnership (DVCRP)

It was noted that completing the paperwork for DVRCP to become a Community Interest Organisation/Company was an ongoing project. At the moment there was not a lot of activity due to the low levels of people using trains.

416.6 Electric No.8 Bus

An application for funding was not made to the current round of CIL Board at Sevenoaks District Council as, at the time of the application process, match funding was required, and the Town Council did not have the funds to provide this. It was understood that this criteria has now changed but, although the Board had been deferred from December to March, new applications could not be submitted.

416.7 Stag Community Arts Centre

It was noted with concern that due to Covid-19 the Stag remained closed and it was uncertain when it might re-open. The Stag had been successful in securing a significant grant award of £444,395 from Arts Council England to assist with the financial challenges relating to the closure.

416.8 Knole Paddock 3G Pitch

It was noted that the Town Council had submitted a planning appeal.

STC & Climate Change Initiatives

Sevenoaks Town Council resources have been invested in recent past in completing major capital projects. Most have now been completed and it is therefore **RECOMMENDED** that the Community Infrastructure Committee adds to its terms of reference the Town Council's Climate Change initiatives as per priority below. This would need to be recommended to a full Council for approval.

In November 2019 Sevenoaks Town Council (STC) resolved to make the following its Number 1 Priority:

- To recognise the Government and KCC declarations for aiming for Zero Carbon.
- To integrate this within the vision and throughout the Neighbourhood Development Plan (NDP) and within the Town Council's general operation.

Community Investment Project 2020/21 Cashflows & use of Capital Receipts Reserve (CRR)

Guidance to the attached spreadsheet:

The following notes explain how the end total of £426,124 is reached.

- January & March F&GP views are as per the committee meetings & included for comparison purposes.
- The top section shows the expenditure on the different community investment projects.
- As at the end of March 2021 (the year end position shared at June F&GP), we had spent £2,127,494 on these projects, with a further £439,751 spend to go.
- The notes indicate how the remaining spend has been calculated. Apologies, the note re Bat & Ball station is now out of date & no longer required.
- The March 2021 CRR year-end balance is £639,367. This is the balance after agreed use of CRR for PWL loan repayment & bus shelters, and 2020/21 project spend not covered by CIL, PWL reserve, grant, or mayor's fundraising.
- Looking at the remaining project expenditure of £439,751, the following will be funded from CIL: £65,000 agreed CIL for hub & drainage, & remaining unspent CIL from original BAT & Ball ancillaries allocation £42,637.
- We also have £121,262 remaining in PWL reserves at year end.
- Deducting the CIL & PWL funding leaves £210,852 of project spend that will need to be funded from CRR. (439,751 – 65000 – 42637 – 121262 = 210852)
- In addition to the community investment projects, we had agreed to spend £2391 of CRR on St John's toilets improvements.
- March 2021 CRR balance of £639,367, less project spend to be funded from CRR & St John's toilets spend leaves £426,123 of CRR unallocated to any project. (639,367 2,391 210,852 = 426,124)

Community Investment Plan Projects

i) Bat & Ball Centre

The Bat & Ball Centre was completed on 4th December 2020. Due to the pandemic, it has been closed to the public. From January 2021 to date KCC has been using the Centre for an Asymptomatic Testing Centre, they are due to return the building to the Town Council at the end of June. There will be some outstanding defect works to be completed internally by the contractor.

An official Opening Event is being planned for 17th July 2021, subject to public health restrictions.

ii) Multi Use Games Area (MUGA)

The installation of the new MUGA has been completed and is being very well used.

iii) Neighbourhood Development Plan

The final amendments for the NDP are currently being considered with the intention, subject to public health guidelines, to have a referendum during 2021.

iv) Sevenoaks Business Hub

The construction of the Business Hub is complete, subject to some additional works to the ramp requested by Building Control, UKPN & BT upgrade. We await news on public health restrictions to promote the rent a desk spaces. The Finance Dept will relocate to the building once the UKPN upgrade has taken place.

v) Darent Valley Community Rail Partnership (DVCRP)

The partnership was launched on 1st September 2019. A Community Rail Officer has been appointed. Proposals for a Community Interest Organisation (CIO) / Company have been agreed by the Partnership and Sevenoaks Town Council has agreed to be the 'Accountable Body' for the new structure. To date the Town Clerk has not had the opportunity to progress the CIO.

vi) Electric No 8 Bus

The project fits within the Town Council's No. 1 Priority of addressing climate change. An application for funding was not made to the current round of CIL Board at Sevenoaks District Council. At the time of the application process match funding was required and the Town Council did not have the funds to provide this – it is understood that this has been changed. In September 2020 KCC agreed to provide two years funding and operate the bus. Sevenoaks Town Council would become a consultee of the service. It is hoped that STC will be able to submit a bid to the next SDC CIL Board.

vii) Stag Community Arts Centre

The Stag were successful in securing two significant grants to assist with the difficult finances relating to the closure. It is now re-open but operating within public health restrictions.

viii) Knole Paddock 3G Pitch

The planning application for the 3G pitch lost at the appeal stage. Some of the allocated funds have been set aside for upgrading floodlighting and drainage to pitches at Knole Paddock.

ix) Bat & Ball Station building

In 2019 Sevenoaks Town Council won first place in the prestigious National Railway Heritage Awards – The Arch Company Award for Urban Heritage. At the Awards Ceremony, the presentation was made by HRH The Princess Royal. Sevenoaks Town Council also received an impressive plaque to showcase on the station building. Unfortunately, due to the pandemic the unveiling of the plaque has been delayed. There is also a further plaque presented by the Railway Heritage Trust. We are pleased to say that we are now in a position to address this, and arrangements have been made for an event on 29th July 2021.

x) STC Offices

To note that during the past 18 months and taking advantage of works to the Business Hub, improvements have been made to the STC Offices including – new upholstery to Chamber chairs, removal of moss from roof, replacement roof tiles, repairs to surface of car park, drainage repairs, upgrade to IT, upgrade to electrical supply, new notice board.

We have also been looking at options for roadside signage for Sevenoaks Town Council, Business Hub, and long-term tenants of the Business Hub. Please see image on next page, the bottom six panels are on tracks so that they can be changed when long term tenants of the pods change. These tenants would be given the option to pay for their business to be displayed. The sign will require planning permission. It will also require an allocation of £3,000 from the Capital Reserves.

RECOMMENDED: To obtain planning permission and install multi business signage at the entrance to Sevenoaks Town Council office car park.
