The Town Council would be the official investment body, and the Committee was mindful that the Town Council would be required to cash flow the project as funding from the Football Foundation would be retrospective.

#### 372.2 Bat & Ball Station

The Committee reviewed the Action Plan monthly report for September 2022 and noted the following in particular:

- Data on website traffic would be of interest
- Arts & Crafts Workshops in August had been well attended and positively received
- Unfortunately, the Heritage Open Day had been cancelled following the death of HM The Queen

- The Heritage Engagement Officer would be discussing roles with potential volunteers
- The proposed once a month holding of a Forget-me-not Café was welcomed and it was requested that a rota be circulated for Councillors to attend
- The posters of railway stations on the Darent Valley line were selling well and cards were now also being prepared for sale
- A Christmas event for children and a Christmas Market would be held in December

The Town Clerk advised that an acoustic report had been obtained in relation to the proposed Railway Children event as amplified music was not permitted under the planning permission. Unfortunately, it was concluded that to reduce the noise level to meet the planning condition, a whole acoustic wall would need to be installed on one side of the building.

### 372.3 Green Community Investment Plan

The Committee reviewed the Action Plan monthly report for September 2022 and noted the following in particular:

- Green Tips for Sevenoaks leaflet had been prepared and uploaded to the website: <u>STC Green Tips for Sevenoaks</u>
- Climate Change Event being organised jointly with SCAN (Sevenoaks Climate Action Network) would be held on 29<sup>th</sup> April 2023
- The need for further bicycle racks would be kept under review particularly in the light of the forthcoming Local Cycling and Walking Infrastructure Plan commissioned by the District Council
- The first Climate Change Youth Forum had been positively received with young people sharing good ideas and keen to move forward
- The exploration of electric vehicle charging solutions continued at District and County Council level
- It was requested that Tunbridge Wells Car Club be contacted to see how their scheme operates
- Suggested that the development of School Travel Plans be discussed with the Climate Change Youth Forum

  - a second meeting with OPC had been held today, 24<sup>th</sup> October 2022, to discuss further how the councils might work together and to set expectations, and the following points agreed:
    - i. Sevenoaks Town Council in principle supported the Otford to Sevenoaks cycle path as per the Sevenoaks District Council Cycling Strategy and the Neighbourhood Development Plan
    - ii. Sevenoaks Town Council would review the relevant 2017 Feasibility Study produced by Kent County Council
    - iii. Consider obtaining a revised Feasibility Study linked to other relevant local proposals
    - iv. Consult on revised Feasibility Study
    - v. Consider adopting detailed scheme to enable submitting future funding applications

#### Progress Report: 31/12/2022

#### Monthly Summary

#### <u>Website</u>

- > Update: Currently working on Graphic Design Banner from STC Social Media and Event Officer, to be at the header of the main front page.
- Researching in animator to have a steam train running through the logo; this is to be updated once Vision ICT have moved onto a different website platform Weebly- the current platform won't allow it.
- > Notified Vision ICT about slow website- they are looking into it.
- Website analytics for December  $1^{st} 31^{st} 2022$  click here
- 1. Social media; Continuing to post and re-share posts regularly on both Twitter and Facebook for Station. Café Manager has own Café at the Station Instagram which he runs himself.
  - It has shown that we get more interactions when the post are more personable; tailoring each post to be more personable and interactive with the community i.e. putting a face to the name of Bat & Ball Station.
  - > Set up timed posts during non-work hours for events.
- 2. Volunteering;
- Continuing to advertise via social media and posters are still up. Social Media posts have been designed and rolled out via Twitter and Facebook. These have has good publicity and well received.
- Imago Volunteer Fair at the Stag October 20<sup>th</sup> completed. Went very well and have recruited 4 new volunteers. Completed a Imago post Fair questionnaire. Forget-me-not café advertising was used at the Fair including volunteer sign up.
- > Oral History volunteer has been disused due to merging with Historic Volunteer role.
- National Trust Knole have been in contact with Youth Council Officer and myself creating and exploring volunteer opportunities for young people in Sevenoaks. They are to attend the new Youth Council Meeting on the 18<sup>th</sup> January with National Trust. Heritage Engagement Officer will also attend, proposal to create a Sevenoaks Town Heritage Youth Volunteering Group; the idea would be to create a collective of opportunities and move them around over a period of time to different sites/places. Sevenoaks is rich of History and Heritage with many places needing volunteers, it would open Heritage spaces to youth and also show career prospects.
- Forget-Me-Not Volunteer morning with Elaine from The Good Care Group; Went well, 1 current volunteer showed up, 3 new volunteers specifically for Forget-Me-Not café.
- 3. Friends of Bat and Ball Station: Printed new FOBB leaflet.
- <u>4.</u> <u>Workshops</u>; No new ones planned for 2023. Heritage Engagement Officer will reassess in January 2023.
- Arts & Crafts education for online; currently researching/ processing videos and tutorials to design create and make at home train station themed; Free pintables will be provided as well.
- <u>5.</u> <u>Railway Children Charity Event</u>; Sound acoustic conducted assessment, completed. The outcome was advised we obtain sound insulation improvements suggested by Able Acoustics: It is recommended that limits are set with the local authority and any amplification system locked in a tamper proof cabinet. It is also recommended that further controls in the form of a noise management plan, with a complaint procedure, be put in place.

- 6. <u>Restoration Celebration</u>: Spoken with a member of the camera club, however he is too busy this year to run the event. Next year might be more flexible.
- 7. Halloween Event;
  - Booked in Station diary.
  - Spooky Halloween Workshop completed. The Creation Station slime and headdress workshop went well, with slime making more popular. All x80 tickets were sold out through EventBrite however only 70-75% families arrived with the inclusion of 5-10% of non-ticketed attendees. Volunteers were very helpful throughout the event, and were relieved earlier due to the event running smoothly. £45 cakes sold during the event. For future reference, it would be good to have café fully open, shrink down the event to x40 children and only have one activity. The Creation Station Sevenoaks are keen to explore more event collaboration with Bat & Ball Station.
  - Halloween Pumpkin Trail: Went very well, with it being popular for local families in the North area of Sevenoaks. STC Town Team Facilitator hasn't any new trails for St John Hill in 2023, this will be reassessed in the New Year; it was agreed in a meeting between STC Town Team Facilitator, Youth Committee Clerk and STC Climate Project Officer that there should be better engagement with other areas of the town including the immediate Sevenoaks Town Centre.
- 8. Silver Sunday;
  - Not successful and resulted in nobody turning up; advertising was done a few months in advance however SDC could've advertised it better on their behalf. If continued next year, different advertising and activity to be used; perhaps a ticketed history talk during café opening hours.
- 9. Environmental Day- Spoken STC Climate Project Officer about engaging the community with the environment. Proposed idea to create a workshop tailored around creating seed bombs, opening the café + being vegan, making gardening workshops. STC Climate Officer has also enquired about getting a bee speaker in for Bat & Ball Community Centre. Could produce a B&B Station workshop for children alongside the event; e.g. making bird feeders or solitary bee houses. Awaiting dates from STC Climate Project Officer.

STC Heritage Engagement officer, Climate Officer, and Youth Committee Clerk are going to organise a Climate Event next year, with the inclusion of speakers/workshops/talks. No Event Plan has been formed, nor a time frame for this event. Meeting to discuss this will be in January 2023.

- SDC DVCRP money set aside for environmental impact. Looking into ways to utilize this.
- <u>10.</u> <u>Heritage Open Day-</u> **Cancelled** due to the Queens Death.
- <u>11.</u> <u>CRP</u>: DVCRP Rail Officer is currently discussing dates for Autumn Art Exhibition; date postponed until November. Loaning posters from National Rail Museum and Transport for London Museum, T&C need to be assessed prior curation design. Proposed to hire display panels for the posters, however DVCRP Rail Officer has mentioned an old Taxi Office at SDC which will be useful for storage if looking to purchase portable white exhibition walls.
- Posters for Sale; selling very well- need to asses cafe selling point of view. Cards with graphic print of posters have been mocked up by Stuart Hillcock, finalizing with DVCRP Rail Officer, to be sold within Bat & Ball Station Café. Posters will also be for sale at the Station Christmas Market
- > Contrado merchandise platform to be set up by DVCRP Rail Officer for DVCRP merchandise including station posters.
- Station Mural; Application currently being completed. Community survey is needed. Local highways also need to be contacts to assess road closure and/or safety. Heritage Engagement Officer to choose muralist>conduct community survey with design drawing.
- > Kent CRP from Hollingbourne Station would like to visit the Station; meeting booked for January

- > Meeting on 28th September completed with Manager from The Good Care Group, SDC Health & Communities Manager, and STC Town Clerk.
- > Volunteer open morning completed: 3 new volunteers showed.
- > Volunteer advert designed, and promoted on social media.
- Speaks have been sourced until May 2023, currently trying to fill all speakers for 2023.
- First launch for café went ahead; is, Over 10+ visitors came and two volunteers, it proved to be a very successful launch. The Town Mayor kindly opened the Café along with Forget-Me-Not Founder Elaine before starting off the event with a talk from Austin Blackburn at Go Coach on his new Art Deco bus garage. There were a few areas to work on; using a microphone, editing opening ours to 10:30-12:30, and making the café feel more 'warm'.

#### 13. Warm Spaces

- > Event Plan for Warm Spaces needs to be formed.
- Warm coats collection has been set up, proving to be very popular. Coats have been redistributed around Sevenoaks Town resulting in more residents getting access to them; House in the Basement and Sevenoaks Foodbank.
- First few mornings, very quiet with nobody showing up. 28<sup>th</sup> November Warm Welcome Space was more successful with 2 visitors and 3 new volunteers.
- Creating list of speakers and events. Slowly beginning to contact speakers- calendar for talks in process. New Volunteers are being very helpful suggesting contacts
- Coat rack, Book Swap, and free teas/coffees provided.

This would be great to integrate Sevenoaks a whole and engage with the community better in the Northern End.
- 16. Christmas Event: Father Christmas meet and great, Christmas tree, and crafts
  - Event Plan needs to be finalized.
  - Volunteers have been contacted; no volunteers are available for this. Sevenoaks Council Team Facilitator has volunteered to be Father Christmas. Station café will need to be open.
  - Advertising: Christmas event to be part of Sevenoaks Town Council Christmas Advertisement collection. Free tickets sold through Eventbrite have sold out.
  - 10<sup>th</sup> December event; Father Christmas made his special appearance, bringing all his Christmas cheer and presents for children who visited him in his wonderful grotto. As part of the event, children could make Victorian inspired crafts such as Christmas crackers, paper angel decoration, and Christmas cards for Father Christmas. Children had a wonderful time meeting him and learning a little about how Christmas through the Victorians. Sevenoaks Town Team Facilitator volunteered kindly to be Father Christmas for the workshop. The Station café opened especially during this market as well, making a good profit and driving customers through to the market. As this was our first market, there were a few tweaks to be made and things to be improved for next year
- <u>18.</u> <u>Awards and Nominations: Awarded Platinum loo of the year award for both Station toilet and platform toilets.</u>
- 19. Signage:
- Investigate Reservoir signage from Kent Wildlife Trust, access from station side into the reserve. Discussed with STC Climate Officer as it would be part the green investment plan for Sevenoaks Town future.
- Sign Scheme confirmed with Town Council for funding. STC Town Team Facilitator Officer and Heritage Engagement Officer will need to discuss how Bat & Ball Station can benefit from this. This project is in it's final stages and costs are being formed, there is no due date.

20. Café:

- Social Media: Station café Manager runs Cafe in the Station Instagram account.
- Looking into advertising signs- Roadside advertising: Café can't be advised due to Sevenoaks District Council Regulations. Cafe sign will be part of the DVCRP mural on the brick wall. More advertising initiatives are needed.
- > Supper Club- Promoted at the Queen Jubilee event revised the event.

Cancelled Yoga collab with Fiscal due yoga instructor's personal issues and stress. They would like to collaborate next year when more prepared and comfortable.

Investigating ways of making the café better integrated into the community; social trends e.g. pumpkin spiced lates, Veganuary. Proposing to also donate to a local charity each month; such as a 'Meal of the month', a particular meal is picked by the café > each of those meals purchased, a percentage of profits goes to a charity picked by the customer/staff.

- > More sites and businesses in Sevenoaks to link up with to promote and collaborate with to be researched.
- Green investment plan regulations- Vegan orientated events are being planned. Assessing gaining sponsorship from local produce companies. Ways to incorporate more green events for 2023 will be looking into with STC Climate Officer.
- ➢ Facilities
  - Damaged Panel by Bat and Ball community center entrance side. Southeastern Facilities Team have the panel, the Station Manager at Sevenoaks is following up with a timeline.
  - > Telephone- Heritage Engagement Officer to complete editing of sound recordings and reinstalled.
  - Station bench- 06/11/2022 the bench was criminally damaged, which has been reported to the police. The arms of the bench were ripped off; Station Facilities Manager has repaired the bench temporarily without arms. David Redfern has been contacted to supply a quote for restoration of bench £1,560.00. Contact Railway Heritage Trust to see about funding, however this isn't a usual area for funding.
  - Construction of platform bench David Redfern has supplied us with a quote for creating a replica of the current platform bench £3,817.60.
  - > Potential to claim on insurance for bench repairs, this might take up to a few months.

#### STC Green Community Investment Plan - December 2022 report Monthly Summary

- 1) Call with David Bagwell from Ubitricity on the 8<sup>th</sup> of December to discuss the potential for a pilot of Lamp post chargers in Sevenoaks. Ubitricity have expressed interest in running a trial in Sevenoaks of up to 10 lamp post or bollard chargers for residents. They are confident that such a scheme would be able to run in the town, and have had SDC approval for a previous project. They will be in touch in January with a plan proposal.
- 2) Meeting with William Rossiter from Mitsubishi/Ecodan on the 8<sup>th</sup> to investigate potential for heat pumps in the council offices and business hub. Space for the heat pump units may need to take up a car parking space on the side of the Council Offices. 2 units per building are estimated, perhaps 3. Loft Insulation will be required for the installations. Glenn Ball has been contacted for details of our buildings, though he has not yet responded.
- 3) Meeting with Faye from the Micro Greens company regarding stocking their goods in the Station Café and also how they can get involved with the Climate Fair in 2023 to be arranged in the New Year.
- 4) Juliet from PV Solar Installers has been in contact regarding the installation of Solar Batteries at the Bat & Ball Centre, stating: "The Community Centre is a high user of electricity. Your existing solar installation will not produce enough excess electricity to fill batteries because your usage during the day exceeds what the panels will make, of course there are moments of exception. However, the benefit of batteries really comes in if you have a cheaper night time tariff from your energy provider; the batteries can be topped up overnight from this cheaper rate. The next day, the Centre will draw electricity first from the solar panels and if this is insufficient, then the batteries, which are full of any excess electricity from the panels and cheaper night time electricity and lastly from the grid at the more expensive day rate. My proposal, assuming you have a cheaper night time rate, would be to remove the existing inverter and add between 1 and 3, 15kWh hybrid inverters and maximise the batteries on each inverter to 23.2kWh. I have included a new estimate showing the cost of one 15kW hybrid inverter with 23kWh of batteries. When I visited the Centre I did not see the existing inverter and assume it is on the roof with the panels. Placing the batteries on the roof with the inverter would also involve some weather protection housing for the batteries, which is not included in this estimate. To add more than one inverter would require a full survey from the electrician. I am being open and transparent with regards the costs. If the electrician costs or material costs are less or different at the time of ordering, this saving would be passed onto you. I am happy to share my supplier invoices with you. With regards potential savings from having batteries, this depends on the difference between the day time and night time tariff. The difference can be as high as 30p."
- 5) Similarly, Paul Vine from OHM energy also noted that the current solar installation at the Bat & Ball Centre is fairly small, and so will not fully benefit from having batteries installed, though these can be filled with cheaper electricity during off peak hours to be used during the day. The installation of a new inverter would allow the electricity generated from the solar panels to be utilised by the Centre and not sold directly to the grid, as well as fill these batteries, too.
- 6) Work on the Carbon Reduction Action Plan is ongoing, with a basic plan set out in excel. This will be edited and updated with different targets, such as solar installation, insulation, and more, for each of STC's buildings.
- 7) A Clothing Bank will be introduced to the Bat & Ball Centre in January for 3 months. This can provide revenue to STC, though there are concerns regarding the appearance and upkeep of the bank, which is why a trial period has been suggested.
- 8) Hard to recycle plastics recycling may be introduced at the Bat & Ball Centre. Procycle by Veolia offers services for crisp packets, sweet wrappers, and healthcare bottles. These could be trialled for a time at the Bat & Ball Centre. Veolia have been contacted for costs of these services, including for the collection of full boxes. Currently awaiting response for the Procycle service, though I have received a response regarding food waste collection, with a 240l bin costing £8.50 per lift, with no rental, delivery, or duty of care fees. Plastic recycling may cost similar. Procycle difficult to recycle items | Veolia UK.
- 9) SDC has stated that they are unable to allow Car Clubs to use any of their charge points in the town centre as these are popular, frequently used locations.

- 10) Liberty charge have been contacted for suggestions on how to introduce EV chargepoints for use by Car Clubs, as they offer fully funded options for EV charge points for local authorities.
- 11) BP pulse have been contacted for some information on the cost of installing EV charge points, and suggested that different funding options are available. Currently awaiting response regarding the cost of an EV charge point.
- 12) The next Climate Change Youth Forum is being organised for the middle of February at 09:30 11:30 in the Bat & Ball Centre. Trevor Kennett from SDC has been invited to talk to the student representatives regarding SDC's recycling policies. Following feedback from previous Youth Forums, a new format will be trialled, whereby we will have different discussions on different tables with different guests before sharing key points, to try and keep the sessions engaging.

## Local councils' powers to address or reduce climate change: existing powers and future opportunities

As a contribution to NALC's work on climate change, the following is a brief commentary on the powers which local councils possess to tackle climate change. Its purpose is encourage thinking within our sector: both about what local councils may do to make effective use of existing powers, and also to recommend changes to current laws and policies, for consideration and adoption as NALC policy.

From the list of powers that are available to local councils, in NALC's publication 'The Good Councillors Guide'

1) Allotments and markets: [Small Holdings and Allotments Act 1908, ss 23, 26 and 42] (Food Act 1984, s. 50)

- This allows the promotion of local produce and healthy eating
- This can help to reduce food-miles
- Allotments powers also enable the provision of communal food-growing sites and initiatives, run by associations and cooperatives.
- 2) Burials etc: [Open Spaces Act 1906, ss 9 &10; Local Government Act 197, s.214; Parish Councils & Burial Authorities (Miscellaneous Provisions) Act 1970 s.1]
- This can allow practices such as green burials, eco-friendly management etc
- 3) Commons, ponds, open spaces, recreation etc (Open Spaces Act 1906, s.15; Highways Act 1980, ss 47]
- Scope to practise good environmental management, accommodate recycling facilities etc on the council's land
- Scope to plant trees on, and maintain, highway verges
- 4) Community centres and other public buildings (Local Government (Miscellaneous Provisions) Act 1970, s.19. (Local Government Act 1972, s. 133)
- Scope to embrace/include on-site green energy, energy-conservation, electric car charging-points etc
- 5) Community energy (s20 of the Climate Change and Sustainable Energy Act 2006)):

- Councils can encourage or promote the local production and use of renewable energy, and also energy conservation, subject to the section 137 of the LG Act 1972 annual spending limit

- However, restrictions currently on the ability to 'sell' the energy directly to local consumers.
- Also, the 's 137 expenditure limit' is a severe constraint on making capital investments in energy schemes

6) Highways and sustainable transport (Highways Act, ss 43, 50, Parish Councils Act 1957, s.1; Local Government Rating Act, 1997, s.25, 28 & 29; Transport Act, 1985, s.106A)

- Scope to promote rights of way routes, walking and cycling
- Scope to use 'car park' powers, to provide useful facilities such as on-site electric vehicle-charging points
- Scope to make more use of powers to support community bus services, and to run or support car- sharing
- 7) Litter and environmental crime ([Litter Act 1983, ss 5.6, Cleaner Neighbourhoods and Environment Act, 2005]
- Scope to provide refuse and waste receptacles and publicity, including recycling
- Scope to discourage and prosecute littering and dumping
- Currently there is no specific power to promote or run waste-recycling or resource re-use activities
- 8) Neighbourhood planning [Localism Act, 2011; Neighbourhood Planning Act, 2017 and National Planning Policy Framework,)
- Scope to include environmentally-friendly planning policies re design, routes, landscaping etc
- There is a continuing need to ensure that Neighbourhood Plans have 'teeth', and that they can be more than just land-use allocation policies.
- 9) Newsletters and websites: (Local Government Act 1972, s.142)
- Scope to use to promote good environmental practices, resource-sharing etc
- 10) Community support and engagement (Local Government Act 1972 ss. 111, 140 etc)
- Scope to encourage and support volunteers and the wider community with grants, loans, insurance protection, publicity, surveys, good-practice advice etc
- 11) Tourism Local Government Act, 1972, s.144
- Scope to encourage and promote eco-tourism
- 12) General powers (Local Government Act 1972, s 137; Localism Act 2011, ss 1-8; )
- Scope to spend money and/or undertake work on a wide range of beneficial activities which are not prescribed in other legislation
- However, s 137 annual spending level is limited, and the General Power of Competence is exercisable by relatively few councils.

STC Green Community Investment Plan – Progress Report. 13) Subsidiary powers (LG Act 1972 s111):

- A very useful enabling power, for a council to do anything (that are not constrained by other legislation).which is calculated to facilitate or is conducive or incidental to the discharge of any of its functions.

14) Permitted development rights (Town and Country Planning (General Permitted Development) (England) Order 2015, part 12):

- Councils may erect and operate, without the need to seek planning permission, a wide variety of small buildings, equipment and other structures on their land, for the purposes of any of their functions or public services. This can include a range of small 'green' developments

Recommendations for NALC policies and services:

a) As part of its range of 'good-practice' publications, NALC is recommended to produce one or a number of Climate Change related material, which includes 'legal advice' on the creative use of the powers already available to local councils, as summarised in this document

b) Local councils should be given a direct power to undertake tree planting and other eco-friendly activities on a much wider range of land, beyond just their own recreational spaces and highway verges.

c) The 'section 137' expenditure limit on community energy facilities and activities should be removed

d) Local councils should be given the power to promote and operate facilities and services to recycle waste and re-use resources.

e) The role and effectiveness of neighbourhood plans in relation to Climate Change should be protected and given more weight in decision-making.

f) Local councils should be given a power to promote and run facilities for their local community which make effective use of ICT (Information and Communications Technology), such as community broadband systems.

## **Car Clubs in Sevenoaks**

Sevenoaks Town Council would like to support the creation of a car club. For this, two options have been explored. These are Enterprise Car Club and Co Wheels. Both of these would help STC progress with the aims of the Green Community Investment Plan, by providing alternative travel options to those who do not own or need a personal vehicle. These cars can be offered hybrid or electric, further benefiting the town by being lower carbon travel. A CoMoUK study found that each car club car takes off 20 private cars from the road. A small fleet in Sevenoaks of 2-3 cars could therefore have the potential to remove 40-60 private cars from Sevenoaks roads, with implications for traffic and air pollution.

Enterprise Car Club would be able to provide fully electric vehicles, and in previous meetings have not indicated the need for any funding from Sevenoaks Town Council. They have carried out research and are optimistic that Sevenoaks would be a viable market for their services. Enterprise Car Club would require a dedicated EV parking bay for each vehicle it introduces. This would need to be in a visible area with high footfall. Sevenoaks Town Council currently has 2 EV chargers, one at the Bat & Ball Centre, and one at the Town Council Offices. If these are not suitable locations, other options include the Enterprise Car Rental site at St Johns Car Park. Sevenoaks Town Council could potentially provide some funding to allow for the installation of an electric vehicle charge point here, should the Car Rental Business provide permission. Another option would have been to collaborate with Sevenoaks District Council, and use electric vehicle charge points in their car parks, with a combination of 2 sites such as the Bat & Ball Centre and an SDC car park in the Town Centre. SDC has stated, however, that they are not able to allow STC or a car club to use their charge points as "dedicating some of them to a car club would not only reduce the availability of charge points for electric vehicle drivers visiting the town centre, but could also affect the commercial viability of the site."

Co Wheels' car club offers petrol, hybrid, and electric vehicles, and as with Enterprise, their research indicates that there is a viable market for their service in Sevenoaks. Co Wheels aims to remain for at least 3 years in their projects to allow sufficient time and opportunity for the business to grow to potential, and would be looking at 2-3 cars for Sevenoaks. Like Enterprise, should electric vehicles be preferred, designated EV bays will be required, with Co Wheels being able to provide signage for these. If hybrid vehicles are chosen, users can return the car to return zones whereby any parking space within a certain radius can be used, or designated bays. Co Wheels would ask that Sevenoaks Town Council and other local environmental groups promote this scheme in all available channels so that a large audience is aware of their services. Co Wheels also typically asks for funding of 75% of the total vehicle cost. This is typically £15,000 per electric vehicle, £11,000 per hybrid vehicle, and £9,500 per petrol vehicle. The delivery time of vehicles is 12 weeks for electric cars and 6 months for hybrid cars. Co Wheels suggest launching in March as the summer months are typically busiest and the business can grow in this period. Co Wheels have been in talks with SDC about setting up a car club in town.

In conclusion, Enterprise Car Club may be a better option if only looking to install electric vehicles, as they do not charge for vehicles. Suitable charging sites for both providers would need to be established by introducing STC EV bays in the town centre. Currently the only locations that STC have are at the Bat and Ball Centre and the Town Council Offices. The Bat and Ball Centre may be a good location for one of the EV bays as it is close to the railway station, offering connections to further transport if required. BP pulse have provided a quote for a 7kw double socket floor mounted

unit of £1,495. Other options include partnering with a company such as Ubitricity or Libertycharge, who offer assistance in finding funding and installing charge points, which could be placed in suitable central locations in the town for car clubs. Ubitricity has stated that the charge points it installs can be used by car clubs, though installing general use charging points first is generally more valuable. A potential way forward is to partner with a company such as Ubitricity to install charging options in the town (in car parks and on street), and following this, dedicate or introduce dedicated bays for a car club to utilise.
