Sevenoaks Town Council - Co Option Policy & Procedure

Introduction

- 1. Co-option is the process by which a parish / town council selects a new Councillor when a vacancy exists on that Council that has not been filled by an electoral process.
- 2. Although the process for co-option is not prescribed in law, the Society of Local Council Clerks and the National Association of Local Councils provide best practice advice and guidelines, and this has been considered in this policy.
- 3. It is especially important that all applicants be treated alike so that the arrangements are seen as open, fair, and transparent.
- 4. The Co-option process to be used by Sevenoaks Town Council is as follows:
- 4.1. Whenever the need for Co-option arises, Sevenoaks Town Council will seek and encourage applications from anyone in the town who is eligible to stand as a Town Councillor.
- 4.2. Councillors or parishioners can legally approach individuals to suggest that they might wish to consider putting their names forward for Co-option.
- 5. The Co-option policy will be reviewed every four years.

Co-Option Policy

- 6. The advertisement to Co-opt will include:
- 6.1 the method by which applications can be made
- the closing date for all applications, at least two weeks' notice to be given.
- 6.3 a contact point to obtain more information
- show that further information is available electronically via the website, to include application forms and information about the roles and responsibilities of the council.
- 7. Existing Town Councillors may point out the vacancies and the process to any qualifying candidate(s).
- 8. Any candidate(s) found to be offering inducements of any kind will be disqualified.

- 9. Those seeking Co-option should apply to be Co-opted in writing to the Chief Executive / Town Clerk completing the prescribed form which will set out their reasons for standing and a confirmation that they meet the eligibility criteria. This must be supplied by the closing date for applications which will be at least 14 days prior to the decision meeting.
- 10. Eligibility of the candidate will be confirmed by Sevenoaks Town Council's Chief Executive / Town Clerk.

- 11. All eligible candidates will be invited, by letter, to attend the next full Sevenoaks Town Council meting following the application deadline. If candidates are unable to attend, this meeting will not be rearranged. The Co-option will still take place and voting on this vacancy will be subsequently based on this meeting and the candidate application form.
- 12. All Town Councillors will receive copies of candidate applications, along with the summons to attend the next full Town Council meeting following the application deadline. Candidate names will be displayed on the agenda of the meeting at which the Co-option will occur. No other details apart from the candidates names will be displayed. Candidate applications are strictly confidential.
- 13. An agenda item will be set aside for candidates to make a brief verbal presentation to Town Councillors, outlining their relevant skills and experience. Each candidate will be allocated a maximum of three minutes. After presentations Town Councillors may ask candidates questions if considered necessary. These presentations and questions will be in public open session.

- 14. The Mayor will then request those Town Councillors present to nominate a candidate to become a Town Councillor. A Co-option to the Town Council is by Council resolution and require a proposer and seconder to progress to the voting stage.
- 15. The Mayor will then place the names of nominated candidates in alphabetical order and proceed to vote.
- 16. A current Town Councillor may request that a signed ballot is used. The Chief Executive / Town Clerk will prepare voting slips for this purpose.
- 17. Only Town Councillors present in person at the meeting may vote upon a person to fill the vacancy. Town Councillors will have one vote per vacancy to be filled.
- 18. If a candidate is a relative of a Town Councillor, that Town Councillor should declare a prejudicial interest and withdraw from the meeting.
- 19. A successful candidate must have received an absolute majority vote by those Town Councillors present.
- 20. It follows that if there are more than two candidates for one vacancy and not one of them at the first count receives a majority over the aggregate votes given to the rest, steps must be taken to strike off the candidate with the least number of votes and the remainder must then be put to the vote again. This process must if necessary be repeated until an absolute majority is obtained.
- 21. The Mayor has the casting vote if necessary.

20-mph in Sevenoaks

Background

Over the past year the topic of introducing further 20-mph speed limits in Sevenoaks has been discussed and consulted on, some of the elements created considerable controversy and concern. The plans and consultations to date have been from KCC and involvement of the Joint Transport Board (JTB), see extract from Minutes later in this document.

It is also noted that Swanley Town Council and Weald Parish Council have carried out their own consultations relating to 20-mph without the involvement of KCC and the JTB.

Sevenoaks Town Council has previously carried out public consultation on the installation of Speed Indication Devices and was complimented by KCC on the professionalism of the consultation.

Taking the above into account it is therefore believed that Sevenoaks Town Council could carry out the consultation on a 20-mph signage scheme for the town.

RECOMMENDED: Sevenoaks Town Council could carry out the consultation on a 20-mph signage scheme for the town.

Update on Sevenoaks Townwide 20mph Proposals

The Chairman introduced the report which presented an update on the Sevenoaks Townwide 20mph scheme. At its meeting on the 15 March 2023 the overlap between the proposed Sevenoaks Townwide 20mph Scheme and the planned cycling routes and the benefits and practicalities of integrating the two schemes was discussed. The Board recommended to KCC that the scheme proceed to an informal consultation of the Sevenoaks Town Council Planning Committee Agenda 03-07-2023 17 Sevenoaks Joint Transportation Board - 8 June 2023 4 revised 20mph speed limit area in Sevenoaks Town and pedestrian crossing on the A225 with due consideration to Sevenoaks's emerging Local Cycling & Walking Infrastructure Plan (LCWIP).

A further meeting between the Sevenoaks Joint Transportation Board Chairman, KCC Member for Sevenoaks Town and KCC Officers took place to discuss how best to progress the consultation. As indicated in the report, there was a desire to progress the town 20mph proposals at the earliest opportunity and proceed to an informal consultation, however, due to an existing heavy workload, KCC was unlikely to be able to commit to a consultation until September or October 2023 at the earliest. Furthermore, funding had not been identified for a further consultation or the implementation of the Sevenoaks Townwide 20mph scheme.

The Chairman explained that in view of the pace of progress being made on the cycling routes, and the recent significant funding awarded for the development of the Otford to Sevenoaks cycling route and consultation, the need to consider the proposed Town 20mph scheme as part of the big picture to deliver Active Travel to the town had become even more relevant. The Chairman also outlined that due to this requirement it was considered important to incorporate further

consultation on the Sevenoaks Townwide 20mph scheme within the proposed cycling route consultations.

Members discussed the report and asked questions of clarification. Some Members expressed the importance of integrating the Sevenoaks LCWIP into the Sevenoaks Townwide 20mph scheme. Other Members expressed concern as to the length of the timetable for the implementation of the scheme.

It was moved by the Chairman and duly seconded that a New Member Working Group be set up with KCC and SDC Officer support to develop a consultation plan for the LCWIP which incorporated the Sevenoaks Townwide 20mph scheme to report back to the next meeting of the Board.

Members of the Board were encouraged to get in touch with the Chairman or Democratic Services Team should they wish to be a part of the Working Group.

Resolved: That a new Member Working Group be set up of JTB Members, with KCC and SDC Officer support, to develop a consultation plan for the LCWIP which incorporated the Sevenoaks Town wide 20mph scheme to report back to the next meeting of the Board.

Extract from Sevenoaks Town Neighbourhood Plan

Aim M4: The Neighbourhood Plan supports the introduction of a 20-mph speed limit close to schools and in some residential areas.

Improving road safety in Sevenoaks could be achieved by:

- Promoting low speed limit regimes in built up residential areas consistent with the government's advice on the setting of local speed limits; and
- Targeting measures to calm traffic in areas of high pedestrian activity including school entrances and shopping areas.

Subject to the outcomes of transport modelling, a 20-mph speed limit in certain locations could help to achieve the aims above and also help to improve the environment for walking and cycling.

Land for Sale in Sevenoaks

When land goes up for sale which has historically been used by the local community, rumours start to circulate.

It was brought to Sevenoaks Town Council's attention that the red land indicated on the below plan, which is currently used for woodland, was being sold and community use displaced. Originally it was thought that both highlighted areas comprising a community sports field (blue) and the woodland (red) were both owned and being sold by KCC.



We now know:

- KCC is registered as owning the blue land freehold, with a 125-year leasehold as of 2014 to Kent Catholic Schools Partnership. This land is not currently for sale.
- KCC does not own the red area known as Longspring Wood which we do know is up for sale, unfortunately already under offer, so too late probably for the Town Council to purchase.

Very rarely, but occasionally land does come up for sale in Sevenoaks. STC will consider putting in place process and 'in principle' resolution to enable STC to obtain additional land if it could be used for community benefit e.g., additional woodland or community orchard.

LONGSPRINGS WOOD Oak Lane, Fig Street, Sevenoaks has come up for sale which seems to fit this criterion. Described as "an opportunity to purchase a parcel of ancient woodland on the outskirts of Sevenoaks extending to 15.69 acres". Guide Price £135,000. However, the land is currently under offer, so the Town Council has likely lost the opportunity to purchase.

Sevenoaks Town Council are investigating whether it is possible to register both pieces of land as Assets of Community Value.

RECOMMENDATION:

- 1. To progress, if possible, the registration of the land as Assets of Community Value.
- 2. To monitor the sale of land and if becomes on the market again, the Town Council to pursue purchase as per its Green Community Investment Plan.

Wednesday Market in Buckhurst Lane

This agenda item has been referred to full Council Meeting from the Open Spaces & Leisure Committee held on 10th July 2023.

RECOMMENDATION: Sevenoaks Town Council to review and or endorse the current policy for persuading Sevenoaks District Council to move the Wednesday market from Buckhurst Lane to the High Street (same position as Saturday market).

Background Information

The Town Council operates three Markets in Sevenoaks – the **Wednesday Market in Buckhurst Lane**, the **High Street Market** on Saturdays, and **Bligh's Market** also on Saturdays.

Following the previous market management company going into bankruptcy and a local petition the Town Council tendered to Sevenoaks District Council for the Wednesday and Saturday markets.

A similar petition persuaded the Town Council to take over the Blighs Saturday market when it was proposed that Blighs no longer found it financially viable to operate.

In April 2023, STC successfully re-tendered for the Market Lease for the Saturday High Street Market and the Market Lease for the Wednesday Market in Buckhurst Lane.

Due to the successful new tender the Wednesday Market is now starting to show a profit.

The Wednesday Market could accommodate approximately 16 pitches of varying sizes. At present, there are 7 regular traders and 2 potential new traders with new traders enquiring regularly about availability. The changes in shopping trends have impacted both High Streets and Markets but there is ample opportunity for expansion of the Wednesday Market now that the Market Lease has been renewed.

Access to the Wednesday Market is convenient for market traders and there is plentiful parking for shoppers next to and opposite the Market site.

Sevenoaks Town Council current policy is to persuade Sevenoaks District Council to move the Wednesday market from Buckhurst Lane to the High Street (same position as Saturday market).

Not all the current stalls would be able to fit into the High Street space.

Saturday High Street market has 5 market traders and is at full capacity.

Saturday Blighs market has provision for 10 market traders and operates mostly at full capacity. The Blighs Market has planning permission for an Arts & Crafts Market.

Policy E4: Support will be given to the retention and development of indoor and outdoor markets and encouragement to the diversification of their offer.

There has been a market in Sevenoaks since the 13th Century and Sevenoaks' markets are an attractive draw for the town centre. The provision of specialists markets (particularly a farmers' market) were supported by the public throughout the consultation of the Neighbourhood Plan. The town's two markets (the general market on Wednesday and 'charter market' on the High Street on Saturday) are operated by the Town Council. The Council will work with stallholders to develop proposals to expand provision and diversify the offer.

Markets offer opportunity for fledgling businesses to trade and often sell local produce and goods. This can benefit both the local economy and the environment.

Sevenoaks District Arts Council (SDAC) receives £2500 per annum to distribute as grants and underwriting to Arts organisations who subscribe annually to the Arts Council.

There is a healthy flow of applications, mainly for underwriting. Support is still largely directed at performative arts, however there is a recently launched scheme for grants to individual artists with a £100 cap.

Funding is inadequate for the number of applications and there is careful debate in the Executive Committee on the validity of applications. We were encouraged by the post-Covid recovery in the number of applications.

SDAC are hosting a showcase event for performing and visual artists in Swanley on 27th September to publicise and increase the number of subscribers.

The National Association of Local Councils (NALC) annual study tour returned for the first time since the COVID-19 pandemic to **Newport Pagnell Town Council** in Buckinghamshire between 27 and 28 June 2023.

I attended a NALC study tour as other councillors were not able to manage the dates. I offered to go with our CEO Linda Larter but at the last minute she was in too much pain to manage the journey. It was unfortunate that she was not there as most people were known to her and I was new. It was a well organised event and the other people were friendly, but Linda has lots of knowledge.

Newport Pagnell has a similar size population, 100 listed buildings, lots of history and open spaces and 16 councillors. The Mayor has been in post for 7 years with his supportive wife. He and the Town Clerk seem to make a strong team. The councillors are not elected on party political lines.

A big difference from Sevenoaks is that most of its functions are outsourced but careful control over contracts and the buildings that it owns. There are problems managing e.g., environmental issues on herbicide and insecticide with the contractors.

I liked the skateboard park covered in bright graffiti art, it was simple but fun. Youth building was next to a grassed area, had a dance studio also for drama, some Town Council offices, kitchen large enough to teach some cooking. Space for homework use. The unusual swimming pool was only for teaching swimming, next to indoor classes and other things. Adaptable for changing fashions of leisure activities and difficulties of employing people was part of their strength.

CIL money from large developments close to Milton Keynes, similar to the challenges of Northern Ward Sevenoaks. 6000 homes near Newport Pagnell but part of Milton Keynes city. 900 new homes on fields as part of Newport Pagnell, but they have good road systems, not medieval ones.

However, there was no all the way weather pitches for sport but a new museum is being made for Aston Martin Cars, should bring in more tourists.

A large wetland open area adjacent to the river is managed by the Town Council creatively. Good interpretation boards .

New signage for the town was developed with artistic community involvement.

I think that sharing ideas in this very open way is beneficial to all of us. I would probably have got more out of the visit with Linda's involvement but nevertheless it was worthwhile.
